### HERITAGE PARK AT PRAIRIE TRAIL PLAT 1

#### LEGAL DESCRIPTION

thence southwesterly 137.10 feet along a compound curve to the right, tangent to the last described curve, along said west line of Lot K, having a radius of 971.50 feet, a delta angle of 08 degrees 05 minutes 08 seconds and a chord distance of 136.99 feet which bears South 07 degrees 03 minutes 11 seconds West;

thence southwesterly 91.54 feet along a reverse curve to the left, tangent to the last described curve, continuing along said west line of Lot K, having a radius of 1058.50 feet, a delta angle of 04 degrees 57 minutes 17 seconds and a chord distance of 91.51 feet which bears South 08 degrees 37 minutes 06 seconds West;

thence southwesterly 23.70 feet along a curve to the left, not tangent to the last described line, having a radius of 1001.50 feet, a delta angle of 01 degree 21 minutes 21 seconds and a chord distance of 23.70 feet which bears South 00 degrees 28 minutes 38

thence southeasterly 39.27 feet along a curve to the left, tangent to the last described line, having a radius of 25.00 feet, a delta angle of 90 degrees 00 minutes 00 seconds and a chord distance of 35.36 feet which bears South 45 degrees 12 minutes 03

thence South 00 degrees 12 minutes 03 seconds East, not tangent to the last described curve, a distance of 55.00 feet; thence southwesterly 39.27 feet along a curve to the left, not tangent to the last described line, having a radius of 25.00 feet, a delta angle of 90 degrees 00 minutes 00 seconds and a chord distance of 35.36 feet which bears South 44 degrees 47 minutes

thence South 89 degrees 47 minutes 57 seconds West, not tangent to the last described curve, a distance of 57.00 feet;

thence northwesterly 39.27 feet along a curve to the left, not tangent to the last described line, having a radius of 25.00 feet, a delta angle of 90 degrees 00 minutes 00 seconds and a chord distance of 35.36 feet which bears North 45 degrees 12 minutes 03 seconds West;

thence South 89 degrees 47 minutes 57 seconds West, tangent to the last described curve, a distance of 635.45 feet;

thence northwesterly 146.84 feet along a curve to the right, tangent to the last described line, having a radius of 977.50 feet, a delta angle of 08 degrees 36 minutes 26 seconds and a chord distance of 146.71 feet which bears North 85 degrees 53 minutes

thence North 08 degrees 24 minutes 23 seconds East, not tangent to the last described curve, a distance of 55.00 feet;

thence northeasterly 39.23 feet along a curve to the left, not tangent to the last described line, having a radius of 25.00 feet, a delta angle of 89 degrees 54 minutes 04 seconds and a chord distance of 35.32 feet which bears North 53 degrees 27 minutes 21 seconds East;

thence northwesterly 557.16 feet along a compound curve to the left, tangent to the last described curve, having a radius of 1272.50 feet, a delta angle of 25 degrees 05 minutes 12 seconds and a chord distance of 552.72 feet which bears North 04 degrees 02 minutes 16 seconds West;

thence northwesterly 38.74 feet along a compound curve to the left, tangent to the last described curve, having a radius of 25.00 feet, a delta angle of 88 degrees 46 minutes 52 seconds and a chord distance of 34.98 feet which bears North 60 degrees 58

thence North 22 degrees 11 minutes 58 seconds West, not tangent to the last described curve, a distance of 55.38 feet;

thence northeasterly 41.83 feet along a curve to the left, not tangent to the last described line, having a radius of 25.00 feet, a delta angle of 95 degrees 52 minutes 29 seconds and a chord distance of 37.12 feet which bears North 26 degrees 31 minutes 23 seconds East, to the southerly extension of the west line of said Outlot U, HERITAGE TOWNHOMES AT PRAIRIE TRAIL

thence northwesterly 303.49 feet along a compound curve to the left, tangent to the last described curve, along said southerly extension of the west line of Outlot U and said west line of Outlot U, having a radius of 1272.50 feet, a delta angle of 13 degrees 39 minutes 53 seconds and a chord distance of 302.77 feet which bears North 28 degrees 14 minutes 48 seconds West;

thence North 54 degrees 55 minutes 15 seconds East, not tangent to the last described curve, a distance of 55.00 feet;

thence southeasterly 38.30 feet along a curve to the left, not tangent to the last described line, having a radius of 25.00 feet, a delta angle of 87 degrees 46 minutes 31 seconds and a chord distance of 34.66 feet which bears South 78 degrees 58 minutes 00 seconds East;

thence North 57 degrees 08 minutes 44 seconds East, tangent to the last described curve, a distance of 35.58 feet;

thence northeasterly 187.53 feet along a curve to the right, tangent to the last described line, having a radius of 327.50 feet, a delta angle of 32 degrees 48 minutes 29 seconds and a chord distance of 184.98 feet which bears North 73 degrees 32 minutes 58 seconds East;

thence North 89 degrees 57 minutes 13 seconds East, tangent to the last described curve, a distance of 205.60 feet;

thence northeasterly 70.26 feet along a curve to the left, tangent to the last described line, having a radius of 1310.00 feet, a delta angle of 03 degrees 04 minutes 23 seconds and a chord distance of 70.25 feet which bears North 88 degrees 25 minutes 01 second East, to said west line of Lot A, HERITAGE TOWNHOMES AT PRAIRIE TRAIL PLAT 1, and the Point of Beginning.




